NAPOLEON PRODUCT WARRANTY



For ODK105 with 700 Series 32-inch BUILT-IN HEADS and Sizzle Zone and ODK105 with PRESTIGE® and PRESTIGE PRO® BUILT-IN HEADS and Sizzle Zone.

President's Limited Lifetime Warranty.

NAPOLEON warrants that the components of your new NAPOLEON product will be free from defects in materials and workmanship from the date of purchase for a period of:

Ceramic infrared side burner, BIB10IR (excluding screen)	Lifetime*
Stainless steel cooking grids	Lifetime*
Countertop	25 years
Stainless steel tube burner	10 years ^{plus 1d}
OASIS modular cabinets	10 years ^{plus 1d}
Hinges, slides, and enclosures	10 years ^{plus 1d}
Stainless steel infrared burner for rotisserie	5 years ^{plus 1d}
Stainless steel sear plates	5 years ^{plus 1d}
All other parts	2 years

^{plus 1d} refers to an extended warranty period, during which we supply spare parts to the purchaser at 50% of the current retail price for the lifetime* of the grill.

^{plus 15} refers to an extended warranty period, during which we supply spare parts to the purchaser at 50% of the current retail price for an additional 15 years.

^{plus 10} refers to an extended warranty period, during which we supply spare part to the purchaser at 50% of the current retail price for an additional 10 years.

*Lifetime refers to a warranty period of 30 years.

This warranty is valid in: the European Union, Switzerland, Andorra, San Marino, Norway, Iceland and Liechtenstein.

The customer's legal entitlements in the event of defects in accordance with WKRL - (EU) 2019/711) are not affected, restricted or altered by the present warranty. The exercise of statutory entitlements is to take place free of charge.

Warranty Conditions and Limitations

NAPOLEON guarantees that its products are free from defects exclusively to the original purchaser, and only insofar as the purchase took place through an official NAPOLEON dealer. The following conditions and restrictions apply:

The present manufacturer's warranty is not transferable nor viable for extension under any circumstances or by any of our representatives.

The gas grill must be installed by a licensed, authorized service technician or contractor. Installation must take place in accordance with the installation instructions provided, as well as all local and national building and fire codes.

This limited warranty does not cover damage caused by improper operation, lack of maintenance, grease fire, environmental exposure, accidents, modification, abuse, or neglect. The installation of spare parts from other manufacturers voids the present warranty. The discoloration of plastic elements due to the application of chemical cleaning agents or exposure to sunlight is not covered under this warranty.

This warranty also excludes any of the following: Scratches, dents, paint defects, coatings, corrosion or discoloration caused by exposure to heat or abrasive and chemical cleaners, as well as chips to porcelain-coated parts and any components used in the installation of the gas grill.

If a part deteriorates to the point where it becomes inoperable (due to rusting or burning through) within the warranty period, the customer will be issued with a replacement part.

After the first year, NAPOLEON has the authority under this warranty (President's Limited Lifetime Warranty, 15 Year Limited Warranty, 10 Year Limited Warranty, 3 Year Limited Warranty) to waive any warranty obligation at its free discretion by refunding the original purchaser to the tune of the wholesale price of the relevant defective warranty parts.

NAPOLEON accepts no responsibility for any installation, labor hours or other costs or expenses associated with the reinstallation of a warranty part. Costs of this nature are not covered by the present warranty.

Notwithstanding any regulations under this warranty (President's Limited Lifetime Warranty, 15 Year Limited Warranty, 10 Year Limited Warranty, 3 Year Limited Warranty), NAPOLEON's liability under this warranty is defined by the foregoing, and does not cover any incidental, consequential, or indirect damage in any case whatsoever.

This warranty defines NAPOLEON's duties and liability with respect to the NAPOLEON gas grill. NAPOLEON assumes no further liability in connection with the sale of this product, nor does it authorize any third party to assume any other liability on its behalf.

NAPOLEON assumes no responsibility for: Overheating, extinguishing of the flame by environmental factors such as strong winds or inadequate ventilation.

NAPOLEON does not accept liability for any damage to the gas grill caused by the weather, hail, rough handling, aggressive chemicals or cleaning agents. Warranty claims must be accompanied by the proof of purchase or a copy thereof stating the serial and model number.

NAPOLEON reserves the right to have the product or any part thereof inspected by one of its representatives prior to the fulfillment of any warranty obligation.

NAPOLEON does not bear shipping costs, labor hours or export duties.

NAPOLEON 25 YEAR COUNTERTOP WARRANTY



1. The warranty covers the following products marketed by Napoleon. The countertop consists of colorbody fine porcelain stoneware classified as Bia-GL class and compliant to all UNI-EN 14411-G requirements. Given the product's high chemical and physical resistance, Napoleon warrants the product against any losses which it may suffer in the event of warping or damage to the upper surface of the slab(s) arising during normal household use, solely as a result of:
 - Contact with hot objects, such as equipment normally used in the kitchen (e.g. pots and pans), within dry heat resistance limits.
 - Absorption of liquids and fats.
 - Exposure to UV rays.
 - Installation outdoors, within the limits stated in the manual.
2. This warranty is valid for 25 years as of the date of product purchase, i.e. the date of invoice, bearing in mind that - due to their technical and production characteristics and their qualities - the products covered thereby may be used solely for household purposes, excluding - therefore - professional purposes and uses.
3. This warranty may be used and will be effective solely if the product is installed at an end consumer's premises. To this end, the purchaser shall provide Napoleon with the documents proving the product purchase/delivery date - more specifically, the invoice, receipt, or equivalent document stating the name of the authorized retailer, the product purchase/delivery date and place, as well as the identification details (type, color and size). The purchaser shall also provide Napoleon with images (corner radius, edging) and technical details pertaining to the product installation. The warranty is forfeited if the purchaser fails to provide the aforesaid documents to Napoleon, or provides false, incomplete, or illegible information.
4. In the event that the defect is promptly reported by the purchaser, Napoleon is entitled to examine, entirely at its absolute discretion, the products in question, by sending a technician to inspect the product in order to establish the nature of the defect and the cause thereof. Any damage attributable to actions/events occurring after the claim was filed, will not be taken into consideration and therefore are not covered by this warranty. The purchaser may request for the product to be replaced at no further cost with another unprocessed product having the same features of the product to be replaced. If the product is no longer produced or is otherwise unavailable for the purposes of prompt replacement, Napoleon will provide an unprocessed product having features similar to those of the product to be replaced.
5. The purchaser must notify Napoleon of any defects in the product and, in any case, inform Napoleon of its intention to use the warranty.
6. This warranty does not cover any defects consisting of aesthetic non-compliances in the material nor any flaws resulting from post-production stages, such as:
 - Shipping and handling in general, including carriage to the place of installation and handling up to the exact point at which the product is installed.
 - Slab processing, i.e. any activities for the shaping, drilling, cutting, assembly, and crafting of the slab in general.
 - Installation, i.e. any activities involved in the cutting and placement of the slab.
 - The application of and/or coupling with other materials prone to changes in sizing and/or resistance features, due - among other things - to weather, humidity, environmental conditions.
 - Changes in color, tone, or shade, or changes in the gloss level of the material as a result of changes occurring naturally over time in the product's various components.

Bearing in mind that the product's particular chemical and physical resistance apply to the upper surface of the product when intact and properly stored in the right conditions, the warranty solely applies to the upper surface of the product, or any portion thereof, provided that it has not undergone processing or installation, as stated above, with any warranty for the lateral surfaces, corners, and edges, including those resulting from processing and installation activities, being expressly excluded. Furthermore, the warranty does not cover cases of misuse and/or inappropriate use and/or mistreatment of the product, such as:

- a) Damage resulting from misuse, including but not limited to:
 - Use of the product for purposes other than those for which it was designed.
 - Use of the product in a way which breaches applicable technical or safety standards.
 - Failure to comply with the user manual and maintenance manual.
 - b) Defects caused by normal wear and tear (scratches, abrasions, breakages).
 - c) Product being installed poorly and/or with damaged or broken components.
 - d) Product being exposed to physical, chemical and mechanical mistreatment.
 - e) Poor preparation or maintenance of the place of installation.
 - f) Use of the product in areas that are prone to extreme climate and temperature changes or in direct contact with flames or, in any case, not in compliance with the technical conditions for which the product was designed.
 - g) Damage or problems caused, either entirely or partly, by force majeure, work site conditions, architectural and engineering design, structural movement, vandalism, accidents, natural disasters, or damage caused by interaction with other products.





- h) Damage/injury caused, either directly and/or indirectly, to persons, property, or animals as a result of failure to comply with the instructions.
 - i) Surface damage attributable to contact with normal utensils (e.g. knives, scissors, cutlery) or household appliances.
- 7. Any action by Napoleon or any party appointed thereby, and likewise any replacement of the product, will take place upon the user's request within the time limits consistent with Napoleon organizational requirements. In any case, Napoleon undertakes, in good faith, to carry out the aforesaid work as quickly as possible and without significant inconvenience to the purchaser. Replacement carried out under the warranty will not result in any extension or renewal of the warranty. The warranty for any products replaced will remain in force solely for the remaining period following the product's replacement through to the expiry of the original period of validity of the warranty covering the product. No other form of warranty and/or compensation may be claimed by the purchaser, it being hereby expressly stated that Napoleon will not be held liable for any direct, indirect, incidental, or consequential damages whatsoever which may arise from the defective nature and/or non-compliance of the products, which must therefore be deemed expressly waived by the purchaser, within the limits permitted by law. Any product replaced under warranty will remain the property of Napoleon.
- 8. The replacement products will be shipped to the purchaser at the arrangement and expense of Napoleon.
- 9. The replacement of the product (if covered by the warranty) will take place at no cost to the purchaser. Therefore, if defects are found in the products which are covered by the warranty, the purchaser is entitled to request the replacement of the product, free of charge. Conversely, where it is found that the defect is not covered by the warranty, all expenses relating to the inspection and any replacement work - including labor, travel, board and lodging, and replacement materials - will be charged to the purchaser.
